### Act 69 (HB 2252 HD1 SD1 CD1)

Act 69 was signed by Governor David Ige and will become effective in July, 2017. HSTA-Retired supported this bill over the last legislative biennium. We are thankful to all our Hawaii County legislators and others who aided in the passage of this bill which has significant impact on seniors. This Act requires hospitals and other health service providers to adopt and maintain written discharge policies that are consistent with recent updated federal regulations.

Each hospital/health service patient can designate a caregiver who can participate in the discharge planning. Prior to the patient's discharge, the caregiver can receive instructions related to the patient's after-care needs. The patient's designated caregiver is notified when the patient's discharge or transfer is to occur. Although some hospitals/health care providers may currently have similar policies, this Act 69 mandates that all health service providers have a policy in place that meets current federal regulations.

#### Did You Know?

Most HMSA members qualify for a program called Care Access Assistance Program (CAAP). This program assists HMSA members with travel for access to specialty care from HMSA participating providers on another island when that care is not available on the member's home island. How does it work? Your doctor has to determine that the appropriate specialty care is not available on your home island. He/she then refers you to an HMSA participating specialist on another island. Your doctor then completes a CAAP request form and faxes it to HMSA prior to your appointment. HMSA's Medical Management department will review the request and notify you by letter if your request meets program guidelines. If the request is approved, you can make your own travel arrangements or have HMSA assist in booking the flight. At you appointment, the physician seen signs a certification letter that you need to submit to HMSA with your air travel receipt. HMSA will reimburse you up to a set amount for each one way segment of your travel. Any needed follow-up appointment to the same provider can be requested by contacting HMSA by phone, fax or e-mail. Up to a maximum of 10 round trips in a calendar year can be requested. If you think you qualify for the Care Access Assistance Program, talk to your primary care doctor or contact HMSA for more details.
