#### **Bylaws & Resolutions Committee Report**

The Bylaws and Resolutions Co-chairs worked on and completed a draft of the Guidelines for Bylaws and Resolutions (BR) Committee for the HSTA -R Governance Manual. The draft was submitted to the Executive Committee and accepted by the HSTA-R Board of Directors at its February 23rd meeting.

BR are reviewing final revisions of all the District and Community Club' Bylaws to be sure that they are in compliance with the HSTA-R Bylaws.

#### **2017 HSTA Convention**

The 2017 HSTA Convention will be held at the Convention Center on April 1-2. HSTA-R co-chairs will be attending the convention as well as attending preand post-convention HSTA CBR Committee meetings on March 31st and April 3, 2017. The CBR committee is presently reviewing proposed items which will be addressed by the Convention.

#### 2017 HSTA-R Convention

Four proposed amendments to the Bylaws have been submitted.

- Proposed Amendment 17-1 brings the names of three HSTA-R committees up to date and updates our bylaws since HSTA has increased the number of committee chairs from one to two in Membership and Government Relations.
- Proposed Amendment 17-2 correctly describes the Treasurer's responsibility regarding the preparation of reports for the accountant of all the HSTA-R accounts.
- Proposed Amendment 17-3 intends to remove two of the Secretary's duties and move them to the President in the HSTA-R Governance Manual currently being compiled.
- Proposed Amendment 17-4 adds an Appendix to HSTA-R's Bylaws to list the six purposes of HSTA-R for easy reference.

No proposed resolutions or new business items have been submitted.

#### **HSTA-Retired Proposed 2017-18 Budget**

Your Budget and Finance Committee presents for adoption at the 2018 Delegate Assembly the proposed 2017-18 Budget based on 1,250 members who pay \$78.00 a year and 4,450 members who pay \$48.00 a year. We have based activities based on a budget of \$311,100.00.

This is a slight decrease from last year but we believe it is a doable budget. We have taken into account the funds for outside services, which includes doing the clerical work that has been done by the Administrator. They will continue to assist the State Treasure with reconciliation of accounts and assist with the payment of vouchers. This is all being done to be more efficient with our manpower.

The Budget and Finance Committee reviewed the expenditures from the 2015-16 year to come up with this proposal. We are confident that you will find the proposed budget to your approval.

ere's a secret to help you transform your life. Eating cherries mimics the effects of NSAIDs like Advil, without the side effects. Patients with Osteoarthritis who drank cherry juice twice a day for three weeks experienced a 50% drop in inflammation.
