HSTA-Retired Distinguished Service Awards

The HSTA-R Distinguished Service Award is presented annually to a HSTA-Retired member, in recognition of their contributions to public education and their communities, including: political action, community organizing, mentoring, and volunteering to help meet educator and community.

To be eligible for this award a member must have been a HSTA-Retired member for at least seven (7) years and be nominated for the award by least two (2) members of the HSTA-Retired Board of Directors. The nominee must embody the outstanding service in any or all of the following:

Involvement in the community as an HSTA-Retired member Involvement in the Association (national, state and/or local) Enhancement of retirees' image in the Association and public education after retirement.

The nominations deadline for the 2022 Distinguished Service Award is March 11, 2022.

The HSTA-Retired President shall appoint a special three-member committee to select the recipient of the award.

The presentation of the Distinguished Service Award shall take place at the 2022 HSTA-Retired Delegate Assembly.
